REQUIREMENTS FOR TRANSFERRING AN OUT OF STATE TITLE TO FLORIDA

1. Original Out of State Title

• If the vehicle is financed or leased, contact them and follow their procedures for an out of state transfer. If they require a written request, you may use our Title Request Form. We advise placing the request promptly as it can take up to 4-6 weeks to receive the title in our office. We can issue a 30-day temporary tag while you process the request if you provide a copy of the out of state registration, Florida insurance, valid ID and \$5.00. Once we receive the title, we will call you to come into the office for processing. Please contact your lienholder/lessor if you have any questions regarding the date they mailed your title to us.

2. Verification of VIN Number (Form 82042)

• The VIN must be physically verified on the Vehicle Identification and Odometer Verification form 82042. A Florida Notary Public, licensed Florida dealer or police officer from any state can verify the VIN. As a service to the public, the Tax Collector's office may also verify the VIN. The Flagler County Sheriff's Office phone number for VIN checks is 386-586-2621. All signatures must be original. VIN verifications are not required on travel trailers, off-highway vehicles, or boats and trailers with an empty weight of 2,000 lbs. or less. Out of country vehicle VIN verifications can only be completed by the DMV Regional DMV office, the phone number is 904-365-2681.

3. Sales Tax

• If you have purchased the vehicle within the last 6 months, or if your title was issued less than 6 months ago, sales tax may be due. You will need to provide a bill of sale or DMV receipt showing purchase price and sales tax paid or proof that you have owned the vehicle for more than 6 months.

4. Proof of State of Florida Insurance

• Please provide proof of current Florida insurance for the vehicle you are titling. Proof of insurance is not required for motorcycles, trailers, boats, mobile homes, or off-highway vehicles.

5. Proof of Photo Identification

- Valid U.S. or Canadian Driver License/ID Card or Passport from any country
- * If a purchaser/owner cannot be present, a Power of Attorney form 82053 may be used and is available online at www.flaglertax.com. A photocopy of the absent individual's identification will be required.
